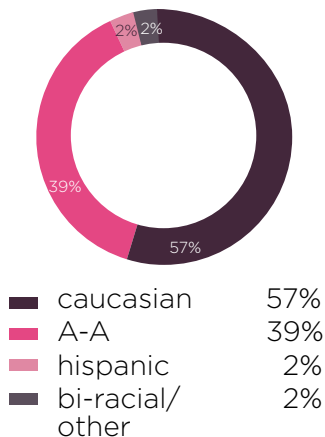
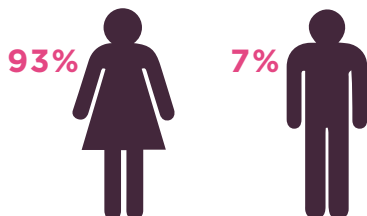

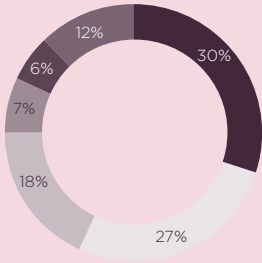

- age range: 3 to 89 years

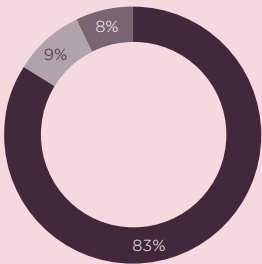

Anne Bruno LaRussa passed away peacefully at home surrounded by her loved ones March 9, 2022. Anne attended John Carroll High School, and married her childhood sweetheart, Benny LaRussa at age 20. Together, with their six children, they built a life centered on family and faith. While her children were still young, Anne returned to school to complete her BA degree in Journalism from Samford University in 1976.



Anne continued her education later in life, and received a master's degree in Counseling from UAB followed by an Ed.S in Counseling from UAB in 1994. She started her career as a licensed professional counselor in mental health clinics in Talladega and Sylacauga. She gained insight into the needs of families in crisis and was passionate about helping others face life's challenges. She was especially touched by the underserved needs of women and children.

With her pattern of grit and determination, she founded Oasis Counseling for Women and Children in 1995. Her vision was to provide a comfortable home-like environment for those receiving services, and she lovingly and capably restored 3 historic homes in Birmingham's southside. Since its inception, Oasis has provided over 45,000 women, children and families with exceptional mental health care. Anne was a bright light that will continue to shine in our hearts and in our community.
