2022 brought us back together in person. Some of our gatherings were joyful and others were tinged with sadness. On March 9th, 2022, we lost our beloved founder, Anne Bruno LaRussa. In 1995, with a vision to provide a comfortable home-like environment for those needing access to counseling, Anne restored 3 historic homes in Birmingham's southside where Oasis is currently housed. Her vision was to provide *exceptional* mental health services to women and children in need. Along the way, she



inspired passion in many who will continue the work now that she is gone. The Oasis of Hope Luncheon held on April 5th was a time to come together to share stories of Anne's impact on us all, while also looking to the future and the continuing need for quality mental health. Personally, I only met Anne a few times, but feel as though I know her more deeply from the stories I have heard shared by her friends and family. She has left a legacy that will continue to provide transformative services for years to come.

At Oasis, we saw a surge in requests for first-time appointments. We hired two new therapists and a full-time intake counselor to keep up with the demand. We continue to utilize Teletherapy to expand our geographical reach and to help local clients that need the flexibility to receive treatment from home or work. We started new rounds of DBT Group therapy.

The leadership team, administrative staff, and counselors work to maintain the warm and welcoming environment that Oasis is known for and to identify new ways to reach clients and increase public awareness of our services. Our Board of Directors and Junior Board continue to be champions for mental health.

Thank you for investing generously in our mission; with your support, we can continue to serve the women and families who bravely reach out to Oasis for care.

our goals

- To connect women and children to quality, professional mental health services.
- To increase our clients' abilities to cope with the challenges in their lives and heal from the hardships of their pasts.
- To ensure all services are affordable, removing cost as a major barrier to treatment.

Oasis clients may have experienced trauma from physical, emotional or sexual abuse; severe depression & chronic anxiety; grief from death or divorce; personality disorders, such as OCPD or Borderline; or difficulties in relationships.

In addition to the previous list, children may also suffer from severe neglect by parents/caregivers; displacement from multiple foster home placement; bullying; trauma resulting from dysfunction in the home due to a parent's substance abuse or mental illness, or witnessing domestic violence even if not a victim.






